### **About the event**

Our 69th Anniversary Virtual Celebration will honor Legal Aid's work throughout this year and offer a sneak-peek into what the organization has coming in 2022.

When the first cases of COVID-19 appeared in late 2019, none of us knew how intensely our lives would be affected. As we approach the two-year mark of the global health crisis, it becomes increasingly apparent the role Community Legal Aid has and must continue to play in keeping our community safe and just.

Throughout this pandemic, Legal Aid has remained vigilant in protecting the rights of low-income Ohioans. Since the early days of the shut-down, our attorneys have been donning masks and heading into courthouses to advocate for survivors of domestic violence, helping them obtain protection orders against the abusers they were suddenly isolated with. Our advocates have worked around the clock to make sure out-of-work residents aren't locked out of the unemployment system or public benefits they need to get through this time. Our team has fought tirelessly to prevent homelessness, to make sure students with special needs get the support they need in adapted learning environments, and to open up employment opportunities for people by lawfully sealing their records.

This work has been non-stop, tiring, and traumatic. But it's also been life-giving to those of us who hold sacred the American value of justice for all. Our 69th Anniversary Virtual Celebration

will honor this work, our advocates and clients, and our vision for a more just and equitable society.
